EXECUTIVE ORDER NO. 036-2020
EXECUTIVE ORDER RESTORING THE CURFEW HOURS
IN CALOOCAN CITY TO 10:00 P.M. UNTIL 5:00 A.M. THE FOLLOWING DAY

WHEREAS, on 15 March 2020, in line with the nation-wide response to the COVID-19 pandemic, the Sangguniang Panlungsod passed City Ordinance No. 0849 s. 2020 entitled “AN ORDINANCE IMPOSING A CURFEW IN THE CITY OF CALOOCAN FROM 8:00 O’CLOCK IN THE EVENING TO 5:00 O’CLOCK IN THE MORNING OF THE FOLLOWING DAY, TO ADDRESS THE WIDESPREAD TRANSMISSION OF THE CORONA VIRUS (COVID-19), AND FOR OTHER PURPOSES”, for the purpose of imposing curfew hours of 8:00 p.m. up to 5:00 a.m. the following day in the City, identifying persons exempt therefrom, and providing for penalties therefor;

WHEREAS, on 17 June 2020, the Sanggunian Panlungsod passed City Ordinance No. 0876 S. 2020 entitled “AN ORDINANCE SHORTENING THE CURFEW HOURS IN THE CITY OF CALOOCAN TO START AT 10:00 PM TO 5:00 AM OF THE FOLLOWING DAY, AMENDING FOR THE PURPOSE, SECTIONS 2 AND 3 OF CITY ORDINANCE NO. 0849 S. 2020” to amend City Ordinance No. 0849 S. 2020 to shorten the curfew hours;

WHEREAS, in August 2020, the Sangguniang Panlungsod enacted Ordinance No. 0889 s. 2020, entitled “AN ORDINANCE AUTHORIZING THE CITY MAYOR TO ADJUST THE CURFEW HOURS SET UNDER CITY ORDINANCE NO. 0849 S. 2020, AS AMENDED BY CITY ORDINANCE NO. 0876 S. 2020, AND TO EXEMPT PERSONS ENGAGED IN TRUCKING, LOGISTICS, COURIER AND DELIVERY SERVICE FROM THE CURFEW HOURS, AND FOR THE PURPOSE, AMENDING SECTIONS 3 AND 5 OF CITY ORDINANCE NO. 0849 S. 2020, AS AMENDED” to authorize the Mayor to adjust the curfew hours as may for the purposes of complying with and the implementing IATF rules and regulations and national government policy on curfew hours, among others.

WHEREAS, by virtue of the re-imposition of the Modified Enhanced Community Quarantine (“MECQ”) in the City from 04 August 2020 until 18 August 2020, the curfew hours in the City were prolonged to 8:00 p.m. up to 5: 00 a.m. the following day.

WHEREAS, with the shift to General Community Quarantine in the National Capital Region, the chief executives of 16 cities and one municipality of Metro Manila agreed to shorten the curfew hours in Metro Manila to 10:00 p.m. to 5:00 a.m. the following day starting 01 September 2020 in order to slowly open up the economy;

WHEREAS, Sec. 455 (b) (vii), R.A. 7160 states that the City Mayor, as Chief Executive shall exercise such powers and perform such duties and functions as provided by the Code and other applicable laws, including to “[c]arry out such emergency measures as may be necessary during and in the aftermath of man-made and natural disasters or calamities;”

NOW THEREFORE, I, OSCAR "OCA" G. MALAPITAN, Mayor of the City of Caloocan, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. *Adjusting the Curfew Hours in the City of Caloocan to 10:00 p.m. until 5:00 a.m. the Following Day.* The curfew hours in Caloocan City is hereby restored to 10:00 p.m. up to 5:00 a.m. the following day.

SECTION 2. *Repealing Clause.* All circulars, issuances, orders or directive inconsistent with this Executive Order area are hereby rescinded or repealed accordingly.

SECTION 3. *Implementing Offices.* The Police National Police-Caloocan, the Department of Public Safety and Traffic Management, Barangay and other authorized City officials, shall enforce the provisions of this Order.

SECTION 4. *Effectivity.* This Order shall take effect immediately.
