<b>AN ORDINANCE ESTABLISHING A CITY HOSPITAL IN CALOOCAN CITY-NORTH, AND APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES.</b>

**WHEREAS**, Section 16 of the Republic Act (RA) No. 7160, otherwise known as the Local Government Code of 1991, provides that “Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom x x x and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety x x x preserve the comfort and convenience of their inhabitants;”

**WHEREAS**, the City Government of Caloocan is resolute in attaining social improvements and better quality of life for its inhabitants, embark on programs and projects that uphold efforts to protect the general welfare and provide the efficient delivery of health services to its citizens, particularly its underprivileged residents;

**WHEREAS**, the proposed site of the new hospital is a parcel of land with a total area consisting of **SIX THOUSAND AND TWENTY-FOUR (6,024) SQUARE METERS**, more or less, located along *Susano Road, Barangay 177, Camarin, Caloocan City, which is a portion of Transfer Certificate of Title No. 242777*, attached hereto as Annex “A”;

**WHEREAS**, in maintaining its efforts to preserve and enrich the historical culture of the City, the proposed hospital in the North shall honor and bear the name of the City, to effect its significance on the historical map as a flagship hospital in the Northern part of the City and shall be known as **CALOOCAN CITY NORTH MEDICAL CENTER (CCNMC)**;

**WHEREAS**, the budgetary requirements for personal services, maintenance and other operating expenditures and capital outlay of the **CCNMC** shall be sourced from the General Funds of this City subject to Section 76 of R.A. 7160.

**WHEREAS**, Sec. 76 of R.A. 7160 provides that “Every LGU shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission”.

**WHEREAS**, in reference to Caloocan City Ordinance No. 0519 Series 2014 entitled “*An Ordinance Amending Section 2 of Ordinance No. 0506 Series of 2013 Enacting Supplemental Budget No.06 for Fiscal Year 2013 to be funded from reverted funds by virtue of City Ordinance No. 0464 Series 2010 for the purpose of providing appropriations for various expenditures*” approved and passed on 25 February 2014, funds have been authorized to be appropriated for the establishment, operation and maintenance of the said hospital;

**WHEREAS**, pursuant to the pertinent provisions under Section 13 of R.A. 7160, the City Health Board has favourably recommended for the establishment of a city hospital in the northern part of the city to effectively address the medical needs of the residents therein.

**NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, BY THE SANGGUNIANG PANLUNGSOD, IN SESSION DULY ASSEMBLED THAT:**

**SECTION 1. OFFICIAL NAME** -The established city hospital of Caloocan City North which is located along Susano Road, Barangay 177, Camarin, Caloocan City, is hereby officially named **CALOOCAN CITY NORTH MEDICAL CENTER (CCNMC)**.

**SECTION 2. APPROPRIATIONS** –The sum of **TWO HUNDRED MILLION NINE HUNDRED TWENTY FOUR THOUSAND EIGHT HUNDRED SEVENTY SIX (P200,924,876.00)** is hereby appropriated to make **CCNMC** fully operational for the year 2015.

**SECTION 3. STAFFING PATTERN** -In order that the aforesaid hospital may effectively discharge the powers and functions as mandated by this Ordinance and in order to provide adequate delivery of health services the following plantilla positions are hereby created:

**SECTION 4.** The qualification standards for the positions of plantilla personnel having the same salary grades employed at the Caloocan City Medical Center shall be adopted for the same or similar positions created under this ordinance.

**SECTION 5. SEPARABILITY CLAUSE-** If for any reasons, any provision of this Ordinance is declared invalid or unconstitutional by a court of competent jurisdiction, the remaining parts thereof not affected thereby shall continue to be in full force and effect.

**Section 6. REPEALING CLAUSE-** All Ordinances, Resolutions, Executive Orders, Memoranda and Administrative Regulations or part thereof in conflict or inconsistent with the provisions of this Ordinance are thereby repealed, amended or modified accordingly.

**Section 7. EFFECTIVITY CLAUSE-** This Ordinance shall take effect immediately upon approval.
